MESSAGE FROM OUR CHAIRMAN



The past 12 months have been a time of both consolidation and forward planning for Anglicare Victoria.

After a year of significant change in which the Agency appointed a new Chief Executive Officer and a new Chairman of the Board, Anglicare Victoria has sought to strengthen its reputation as a trusted provider of high quality services to families and individuals in need and at the same time lay the groundwork for future growth.

The cornerstone of this has been the preparation of a new Strategic Plan that will carry the Agency forward over the next five years.

The Agency will remain committed to delivering life-changing services for the most vulnerable in our community and will speak out on their behalf to advocate for long term solutions.

But this work is being carried out in an ever-changing environment.

The needs of our clients are changing and in turn so are the needs of our workforce, our supporters and our funding bodies.

Families and individuals who turn to Anglicare Victoria for support are experiencing increasingly complex issues and are in need of more comprehensive and innovative support than in the past.

Our family service programs are working together with vulnerable parents to strengthen their capacity to provide the best environment for their children to grow and thrive in, utilising a range of creative strategies.

Many in the community continue to feel the effects of the Global Financial Crisis. In the past 12 months we have seen a staggering 52 per cent increase in demand for financial counselling and provided emergency food and material aid to more than 60,000 people. We continue to see the stress of hardship manifest itself in family breakdown, violence, alcohol abuse and other destructive behaviour.

Children and young people in State care remain a focus for the Agency. We continue to undertake important research in this area to build a better understanding of children's needs and to speak to government about the best ways to improve outcomes for this vulnerable group.

This year we released the report *All Together Now* which uncovered the extent to which siblings were separated within the care system and the impact this can have on children's lives in the long term.

The Victorian Minister for Community Services, Mary Wooldridge, launched the report and the findings received widespread media coverage.

Our previous report *Care system Impacts on Academic Outcomes* continues to receive attention for its findings on the education outcomes of children in care. It has provided us with the impetus to campaign for improved government funding and joined up services to ensure children in care receive all the opportunities a good education can provide.

Thanks to funding from the Leith Trust, we have been able to develop a ground breaking program to support young people leaving State care with education, employment, housing or other life skills through to the age of 21 rather than the current age of 18.

The breadth and depth of our practice wisdom, our research and our advocacy was drawn together recently for our submission to the Protecting Victoria's Vulnerable Children Inquiry. The results of the Panel's findings will not be known until early next year. In the meantime, we will continue to respond to the needs of young people in care and advocate to improve outcomes in their lives.

The continuing debate around refugees and the Federal Government's decision to release all unaccompanied minors into community detention has provided Anglicare Victoria with an opportunity to expand its work and offer housing and support to this particularly vulnerable group.

Our experience working with young people in residential care provided us with the perfect foundation for our growth into this area.

Our work, of course, would not be possible without our dedicated staff, passionate volunteers, generous supporters, Board, senior management and other service providers. I would like to extend my heartfelt thanks to all those involved with Anglicare Victoria for their commitment over the past 12 months.

We endeavour to continually improve our relationships with key stakeholders and our resources in order to deliver the most effective services for Victorians in need.

To this end, we have undergone a restructure of our regional management team and undertaken a full review of administration within the Agency including work to significantly upgrade our IT infrastructure.

With this work soon to be completed, Anglicare Victoria will be well placed to continue serving the needs of the State's most vulnerable children, young people and families over the coming 12 months and beyond.

It is with great pleasure that we present our Annual Report for 2010/11.

In last year's Annual Report I wrote about our desire to be an organisation that is aspirational for its clients, developmental in its programs and relationship driven with its stakeholders and funding bodies.

It is very pleasing that over the past year we have begun to take some significant steps in this direction. We have restructured the operations of the organisation to a regional arrangement in line with government regions to bring better management, leadership and government contact to our service delivery.

We have developed new streams of service delivery in the areas of unaccompanied minors housing and support, an innovative new leaving care service, and a widening delivery of no interest loan schemes or low cost credit to our many families in financial hardship. And importantly we continue to develop our message to our many donors and supporters on what we want to achieve for children and young people within Anglicare.

Whilst these developments represent a good start, we really have only taken early steps in further strengthening and growing Anglicare Victoria.

Fundamentally as an organisation we want to be ambitious for the clients with whom we work. I believe that if we are clearly ambitious for them, we will push ourselves to develop the right programs that can positively and directly influence their future life trajectory.

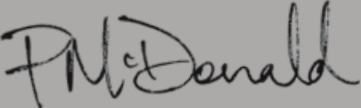

GIVING STABILITY AND HOPE TO CHILDREN AND YOUNG PEOPLE

HELPING YOUNG PEOPLE STAND ON THEIR OWN TWO FEET

Traditionally, young people in out-of-home care receive little real support once they turn 18. Anglicare Victoria recognises this is a critical time in any young person’s life and particularly for someone who has experienced significant trauma.

With this in mind, Anglicare sought and secured funding from the Leith Trust to develop a ground breaking Leaving Care Program to prepare young people leaving State care and support them until the age of 21 with employment, education and housing opportunities.

The pilot program will run for the next three years.

OPENING UP NEW POSSIBILITIES

Young people from disadvantaged backgrounds are often exposed to poor role models and sometimes see little future for themselves other than the life their parents and elders have lived.

Anglicare Victoria is seeking to show young people what is possible by taking children living in residential care on short interstate ‘learning holidays’.

In the past year, we took one group to the Northern Territory while another group went to Queensland. The trips offer a therapeutic adventure, taking the young people outside normal routines and introducing them to new and challenging social and learning situations in a supported way.

The travel allows young people to grow from their new experiences – and sometimes spurs them into making changes in their lives and relationships.



THERAPEUTIC SUPPORT TO OVERCOME TRAUMA

Anglicare Victoria has partnered with the Australian Childhood Foundation to offer intensive support including qualified therapists and other professionals for children who have suffered significant trauma as well as the families that care for them in the foster system.

The goal of these targeted programs (Circle and TraCK) is to keep children in stable placements so progress can be made on their behavioural and psychological issues.

The programs have proven a great success in helping foster families provide long term nurturing homes for some of our most vulnerable children.

LEARNING TO PARENT AGAIN

Kinship carers are grandparents, aunts, uncles, siblings or close family friends who agree to care for children when their parents can’t due to injury, mental illness, drug and alcohol issues or a sudden death.

While the number of kinship carers continues to grow, there is little support to help them learn the skills they need to parent again after years without children of their own.

Anglicare Victoria supports 73 kinship families and offers a program called Parenting Again to help them on their journey. The program teaches kinship carers about working with children and the grief, loss and trauma they have experienced in their lives.

The workshops link carers into support services and provide access to counsellors and child protection experts.

TURNING LIFE AROUND

Tom* is 17 years old and began living in a residential care unit in 2007. He suffered sustained neglect and abuse as a child, causing him significant trauma.

His mother’s partner was violent and there was drug abuse by both adults. Tom doesn’t remember much of his childhood except for repeated beatings, often whilst trying to protect his mother. He often starved and was handcuffed to chairs for punishment.

At the age of just ten, Tom found his mother in bed and was unable to wake her. He rang an ambulance and went alone with her to the hospital where she was pronounced dead.

When Tom came to us he was very quiet and removed. Tom’s Anglicare case worker arranged for one-on-one therapy to help him overcome his grief, loss and attachment issues. This therapy lasted two years.

Due to his neglect and other issues, Tom spent a long time out of school. Getting him back into education was a priority and our education specialist

worked hard to find a day program that suited his needs. We are happy to report that Tom was able to slowly build up his attendance to full time and is now completing his senior VCAL (VCE equivalent).

As his life began to turn around, Tom wanted to try to find his biological father. Through an extensive search by his care team, Tom’s records were recovered, DNA tests carried out and Tom reunited with his dad.

His father and his extended paternal family were shocked to hear about his past and have embraced Tom. After much counselling and support, Tom has transitioned into the family home and he and his father are building their relationship.



PARENTING AGAIN

Four-year-old twins Pia and Claudia, and their older brother Alex*, have been through a lot for children so young.

Their mother is unable to care for them due to substance abuse issues and has not always provided a safe home for her children.

As a result, Alex had taken on a caring role for his sisters and the burden weighed heavily on his young shoulders.

The children now live with their grandmother, Lynne, but she has had to face a range of new challenges to care for these children she loves dearly.

Lynne says the girls often break down and cry for no obvious reason and have attachment issues which limit her ability to leave them in the care of others.

Alex still struggles with his fear and anger resulting from taking on adult responsibilities at the age of eight. Previously, when the girls misbehaved, it was Alex who was punished.

After struggling to manage the children’s behaviour and meet their emotional needs, Lynne was told about Anglicare Victoria’s Parenting Again program for kinship carers. She was able to access a case worker, therapeutic and practical support to help her understand what the children were going through and offer them the support they needed.

Lynne says that by learning these coping skills she has been able to focus on parenting and creating a new life together with her grandchildren.

HELPING PARENTS
WITH SUBSTANCE
ABUSE ISSUES AND
MENTAL ILLNESS

The 'Emerge' program in the Yarra Ranges helps parents with mental health, substance abuse and neglect issues reconnect with their children and build positive relationships. Family therapy facilitators provide therapeutic, educational and psycho-social support to improve parents' mental and emotional health and develop positive coping strategies for parenting and living. The program aims to help before families reach crisis point. Transport and childcare are provided.

Anglicare Victoria's Parentzone programs work with more than 4,500 parents each year to avoid family breakdown and strengthen families.

Our programs give parents skills to overcome conflict, to manage work/life balance and to be a positive influence in their child's life.

Parents share their stories and discover they're not alone in the complex job of raising children. The support often brings about change and helps individuals connect with others in the community.

RESPONDING
TO CHILDHOOD
EXPOSURE TO
FAMILY VIOLENCE
AND TRAUMA

The Child Focused Counselling & Support Team in Broadmeadows has been developed to respond to the trauma children face from witnessing or experiencing family violence.

Children growing up with violence are at increased risk of mental health, behavioral and learning difficulties and often have significant issues with relationships. The team work specifically with children between three and 18 years of age in the Northern metropolitan region in partnership with Berry Street Family Services.

BUILDING
NETWORKS
TO SUPPORT
FAMILIES
IN CARDINIA

Anglicare Victoria is working in the Shire of Cardinia to help build a network of services to ensure children with complex needs are able to access support.

We have secured funding for a range of local programs including

- Beyond the violence – training for staff dealing with parents and children affected by violence
- Library has legs – a program to encourage reading and form a bond between child and parent in homes that are at risk of intervention by Child Protection
- Pregnant and parenting – a program for expecting and new parents at risk of intervention by Child Protection to teach parenting skills and provide therapy and case management for ongoing issues. The program continues until children are six months old.
- School attendance program – a practical program to encourage 'at risk' children to attend school. A case worker ensures clear communication between home and school and often helps facilitate attendance through actions such as turning up at the child's house to make sure the child is out of bed and on their way.



EMERGING FROM DARK TIMES

Sam* joined the Emerge group during a very stressful period in her life. She suffered from a mental illness, her relationship with her partner had broken down shortly after the birth of her daughter and she was finding it difficult to cope.

Sam was also anxious about the judgments she experienced from both her family and the outside world. Her stress was compounded by the fact that she lived alone and didn't drive. At times she got caught up in what she refers to as a 'don't care spiral,' by isolating herself and getting tangled in old patterns of behaviour.

Coming to the Emerge program was a relief for Sam. She had space for herself and time to bond with her new daughter, Alice. It was a place where she could make friends and relax. In the playgroup, she watched how the facilitators communicated with Alice.

"It taught me to communicate more appropriately," says Sam. "In the group, I could talk about my difficulties and explore ways of resolving them."



BECAUSE DADS MATTER TOO

Darryl Appleton was not happy with the way he was parenting. He didn't understand where his children were coming from, and says too often he would react in anger or walk away.

Recognising that he and his kids were drifting apart, he wanted to make some big changes.

On the suggestion of his wife, Darryl attended the Dads Matter workshop run by Anglicare Victoria's Parentzone program. It changed everything.

The six week course is run by a skilled facilitator in partnership with Mensline. Dads come together in a supportive place to speak of the challenges they face, such as work/life balance and better communicating with their kids.

Darryl says input and practical advice from the other men and program coordinators gave him an understanding of his children and the different way they think.

"I used to get angry over things building up and then walk out and never let my kids know how I was feeling. With the help of Dads Matter I now talk to them all the time. I'll say 'let's see if we can work this out'. I want to help them," says Darryl.

The family dynamic has improved dramatically and along the way, Darryl has made good friends with several other Dads from the group. He says the program allows men to feel relaxed and safe about sharing their parenting stories.

"The kids say I've changed and they are more open with me. Our relationship is so much better."

SPECIALIST SUPPORT FOR YOUTH, FAMILIES AND ADULTS

CRIMINAL JUSTICE MINISTRY

Anglican Criminal Justice Ministry provides support for prisoners and their families in Victoria’s 13 prisons and Youth Detention centres. We held Church services for 2,844 prisoners and provided pastoral care to 6,638 prisoners, family members and prison staff in the past year.

It costs on average \$90,000 per annum to hold each person in Victoria’s prisons. The greater but more difficult cost to measure is the effect of removing people from their families and the community. Family breakdown and loss of social networks contributes to the challenging task of establishing a positive life path on release from prison. Accommodation, employment and a supportive community are essential.

Working with the other Faith Communities involved in Prison Chaplaincy, Anglicare is currently exploring ways to assist in the provision of more effective post release support to deliver sustainable rehabilitation for the wellbeing of the entire community.

ALLEVIATING FINANCIAL HARDSHIP

Demand for financial counselling continues to be very high across all areas, particularly in rural centres such as Wangaratta, Gippsland and Melbourne’s West. In the past 12 months our financial counselling teams have delivered advice to, and negotiated on behalf of, 10,553 Victorians facing significant hardship.

We are pleased to have secured extra funding for these services which operate from 13 locations across the State.

KEEPING PEOPLE OUT OF THE JUSTICE SYSTEM

Anglicare Victoria aims to tackle the over-representation of Indigenous people in the juvenile justice system by encouraging young Aboriginal people to improve cultural awareness, connectedness and identity.

The Koori Youth Justice program, in partnership with the Department of Youth Justice and Koori community groups and elders, works with Indigenous young people aged 10-20 currently on Youth Justice Orders. The program also seeks to keep young people out of the justice system and avoid ongoing contact with the system by supporting Indigenous elders in their efforts to ensure young people see out their community service and probation sentences.

COMMUNITY LEGAL SERVICE

Anglicare Victoria’s Community Legal Service in Gippsland offers free legal advice and limited case work to disadvantaged members of the local community.

We supported 561 people in the past 12 months with advice, advocacy and case work on issues such as family law, discrimination and equal opportunity, fines and court proceedings. We also provided support for victims of crime.

The Legal Service has been running for 10 years and is the only service of its kind in the entire region which covers a land mass equal to 18 per cent of the state.

HELPING TEENAGE SUBSTANCE ABUSERS GET BACK ON TRACK



Mary* was in grade five when she was taken out of school to become a full-time carer for her younger brother and her mum who suffers from a debilitating mental illness.

At age 13 Mary returned to school but struggled to cope with the transition and had difficulties making friends. Eventually she fell in with a group of peers and felt she had to drink and smoke cannabis in order to be accepted.

Over time Mary became dependent on alcohol and drugs to help her deal with the pressures of school and her responsibilities at home. It was then Mary was referred to Anglicare Victoria’s Linking Youth and Families Together (LYFT) program.

For five months Mary was part of LYFT, which provides education, rehabilitation and treatment for teenagers with substance abuse issues as well as support for their families.

Although Mary still has a long way to go, her case worker says she is well on the way to getting her life back on track. She is no longer drinking or smoking cannabis and is making progress at school.

Mary and her family are now receiving the help they need and are free to enjoy being together.

KEEPING YOUNG PEOPLE SAFE FROM SUICIDE

Our Blue Heelers Children and Youth Program is a suicide prevention service for high risk Indigenous children aged 8-12 years old in regional Victoria.

The program runs every Monday after school and the children have a meal, play sport, create art and talk about their challenges, hopes and concerns with a dedicated group of volunteers.

The program has shown initial success and there are plans to expand the service to include conflict resolution and life skills workshops.

SUPPORTING REFUGEES AND MIGRANTS

Anglicare Victoria, in partnership with the Federal Government Refugee Settlement Grants Program, assesses the needs of refugees in the Gippsland area and works on a case-by-case basis to address these needs.

This may involve referring individuals or families to housing, education and employment services as well as putting them in touch with other community programs such as English language classes. The program aims to help newly arrived refugees become active members of their local communities.

HELPING YOUNG MOTHERS MAKE CONNECTIONS

Doctors and mental health professionals have recently started referring single or isolated young mothers to our Mainly Music™ playgroup to alleviate social isolation in regional Victoria.

More than 200 families now take part in the music classes for pre-school aged children and as a result of this success, the Bendigo Bank in Heyfield, Gippsland, has donated \$12,000 to build a playground near the church centre where one of the groups gathers.

HELPING REFUGEE CHILDREN PREPARE FOR SCHOOL

What started as a sewing group for Sudanese women at a Church in Box Hill has blossomed into child care, a kindergarten and a small social enterprise that has helped an entire community learn new skills and prepare their children for the Australian education system.

The group employs a professional kinder teacher and together with volunteers they care for the children and teach them social and academic skills in preparation for school.

This leaves the women free to learn sewing skills to make clothes for their families as well as robes for the Anglican clergy.

LEARNING YOU'RE NOT ALONE



Jane left war torn Sudan to find a better life in Australia. But when she arrived here she found herself feeling alone and raising her children without the support of her family and friends.

"I'm just here by myself," says Jane. "I haven't got my parents or family here."

To overcome this isolation, Jane joined Anglicare Victoria's Sudanese sewing group in Box Hill. The group meet weekly and, with help from our volunteers, has learnt the skills to make clothing for their families and for sale.

"For me, sewing group is a good time to be with other women. When we come together as a group you can hear different stories and some are similar to yours, then you can say, 'I am not only by myself, there are a lot of us like me'.

"Sewing group means a lot to me because it gives me lots of skills and experience. Now I can make robes for priests, last year I made robes for the Bishop," says Jane.

"It really makes me feel happier because this is something I would've really liked to do when I was growing up and I didn't get the opportunity."

The volunteers have helped set up child care and kindergarten with a paid professional teacher, so while the women are learning to sew, their pre-school aged children can learn important life and social skills.

"The group helps them so they are ready to go to kinder or school, they get a lot of experience here."



OUR RESEARCH AND ADVOCACY

RESULTS OF OUR FOSTER CARE SURVEY REVEALED THAT 43 PER CENT OF SIBLINGS IN CARE WERE SEPARATED FROM ALL THEIR BROTHERS AND SISTERS WHILE 81 PER CENT OF CHILDREN WERE SEPARATED FROM AT LEAST ONE SIBLING.

The role of Anglicare Victoria's Policy, Research and Innovation (PRI) unit is to drive innovation in service delivery and influence directions in social policy. It does so by undertaking research, service development and advocacy that is informed by the wisdom and experience of our staff and clients.

In 2010-11 the PRI unit completed several research activities on social issues.

The **Foster Carer Survey 2010** explored the issue of sibling separation in out-of-home care. Results of the survey revealed that 43 per cent of siblings in care were separated from all their brothers and sisters while 81 per cent of children were separated from at least one sibling. The report from the survey, called *All Together Now*, was the subject of multiple feature articles in The Age. The launch of the report also received TV and radio coverage.

The **Hardship Survey 2011** included a regular monitor of deprivation and explored how people receiving emergency relief services were spending government allowances. The survey showed that cost of living pressures were leading many people to overspend and slide into debt just to pay for basic items such as housing, food and utilities. The research was the subject of news stories on three TV stations. It also received coverage in the Herald Sun and on radio as well as a feature article and an Op Ed online.

The **Rental Affordability Snapshot 2011** showed less than 1 per cent of rental housing in metropolitan Melbourne was

affordable to those on income support. This research was covered on two TV stations and six radio stations.

The **Gippsland Legal Needs Analysis** revealed a population with a high level of legal needs and barriers to justice. Almost three-quarters of people surveyed from a variety of community service locations experienced a legal issue with more than half of these issues having occurred within the past 12 months.

The Unit also evaluated new service models and programs. This included local evaluations of the Communities for Children and Communities for Children Plus programs in North Frankston and Cardinia.

The Agency's reputation for delivering quality out-of-home care services was enhanced through development and delivery of new training in the use of Looking After Children – a best practice approach to improving outcomes among children and young people in out-of-home care.

Findings from research on the education outcomes of children in out-of-home care were widely disseminated to promote an evidence-informed approach to service development.

The Agency emphasised its wisdom and influence on social issues through publication of Opinion pieces from both CEO Paul McDonald and GM Policy, Research and Innovation Dr Sarah Wise in The Age on issues including out-of-home care and equitable wealth distribution.

OUR SUBMISSION ESTABLISHED A SET OF RECOMMENDATIONS FOR A SYSTEM THAT PROTECTS VULNERABLE CHILDREN AND PROMOTES DEVELOPMENT AND RECOVERY AMONG CHILDREN, YOUTH AND FAMILIES WHO HAVE EXPERIENCED DISADVANTAGE, DYSFUNCTION, ABUSE AND/OR NEGLECT.

INFLUENCING POLICY TO IMPROVE OUTCOMES FOR CHILDREN AND FAMILIES

Early in 2011 the Victorian Government established the **Protecting Victoria's Vulnerable Children Inquiry** to comprehensively investigate systemic problems in Victoria's child protection system and to make recommendations to strengthen and improve the protection and support of vulnerable young Victorians.

Anglicare Victoria prepared a 45 page written submission that responded to the Inquiry's overall focus. The submission established a set of recommendations for a system that protects vulnerable children and promotes development and recovery among children, youth and families who have experienced disadvantage, dysfunction, abuse and/or neglect.

The submission is punctuated with case studies provided by Anglicare Victoria practitioners that highlight and evidence the Agency's position on challenges that are manifest within the system. Anglicare Victoria's written submission was followed-up with a verbal submission at the Public Sitting in Melbourne.

Anglicare Victoria also initiated a process with key providers and other experts in child and family welfare that resulted in a combined submission to the Vulnerable Children's Inquiry from a coalition of Community Service Agencies including MacKillop Family Services,

Berry Street Victoria, VACCA, the Salvation Army and the Centre for Excellence in Child and Family Welfare. A verbal submission was also made at the Public Sitting in Melbourne.

Anglicare Victoria also made a submission in response to the CREATE Foundation's **Learn or Earn Discussion Paper**, which aimed to advance thinking on how to achieve better educational, training and employment outcomes for children and young people in care or post-care. The submission, prepared with Wesley Mission Victoria, was based on the extensive experience of both Agencies delivering out-of-home care as well as research both Agencies have undertaken in the out-of-home care and leaving care areas.



OUR STAFF

A number of initiatives have contributed to the professional development of our staff in the past year and are making a solid contribution to our key organisational objective of becoming an employer of first choice.

- Our Learning @ Anglicare Victoria is a comprehensive professional development program that is centred on further enhancing the knowledge and practices of an already skilled workforce. With over 30 professional development activities, the program had over 557 participants in the past year.
- Our Graduate Certificate in Advanced Family Support Practice was developed in conjunction with RMIT and is designed to develop the skills of program managers, team leaders and practitioners. The innovative program is now attracting interest from other community service organisations.
- A new format was introduced for the annual Chairman's Awards with eight exciting categories. There are now awards for individual staff members, staff teams, for volunteers and client achievements.

- We commenced the development of our next strategic plan with a two day leadership conference to discuss the future directions for Anglicare Victoria. The ideas, themes and suggestions that came from this two day conference were discussed with over 200 staff during a series of consultation sessions.
- We developed an induction program for staff commencing our Community Detention Unaccompanied Minors Program. The program will be progressively conducted for relevant staff on a regional basis.

VOLUNTEERS ARE A VITAL PART OF THE ANGLICARE VICTORIA TEAM. WE HAVE OVER 700 VOLUNTEERS ACROSS THE STATE WHO CONTRIBUTED MORE THAN 14,000 HOURS OF WORK OVER THE PAST YEAR.

OUR VOLUNTEERS



FOSTER CARE

Foster families are our most important asset to help turn around the lives of children who have suffered serious abuse and neglect. Carers are supported with training and professional support to cope with particularly challenging children.

MENTORS FOR BOYS

Volunteers in the Yarra Ranges act as mentors to guide socially disadvantaged and at-risk boys from adolescence to manhood. The men and boys complete activities such as mountain bike riding, a ropes course, bush walking and camping to build their relationship and demonstrate positive behaviour.



EMERGENCY RELIEF

Hundreds of volunteers across the state help families and individuals access emergency food and other material aid when times are tough. Without these dedicated volunteers, these services could not operate.

HOMELESS SERVICES

With the support of volunteers, Anglicare Victoria offers a range of services to the homeless including meals, a drop in centre, referrals to specialists and a place to shower and clean clothes.

HELPING REFUGEES AND MIGRANT CONNECT

Through programs such as sewing groups, community gardens, cooking classes and parenting classes, volunteers are helping refugees and recently arrived migrants settle into local communities and learn new skills. Volunteers also help us run child care and kindergarten programs for refugee and migrant children in Melbourne's East.

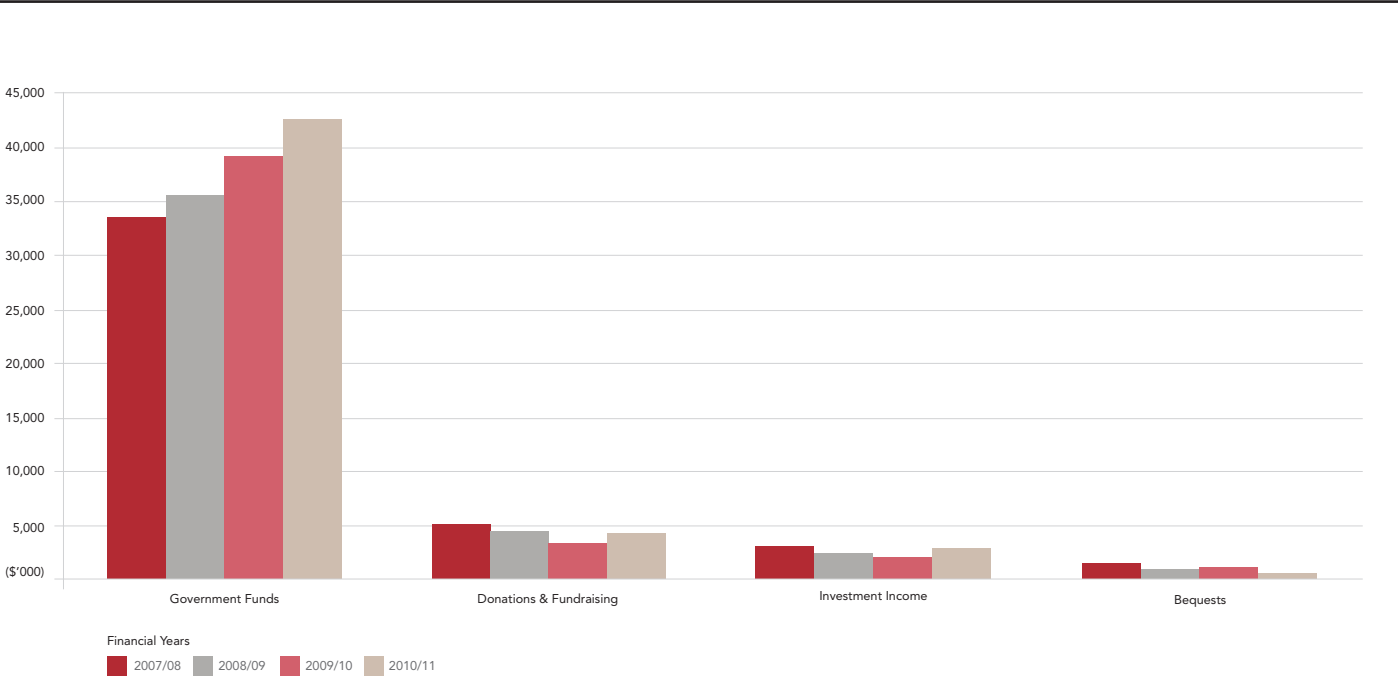

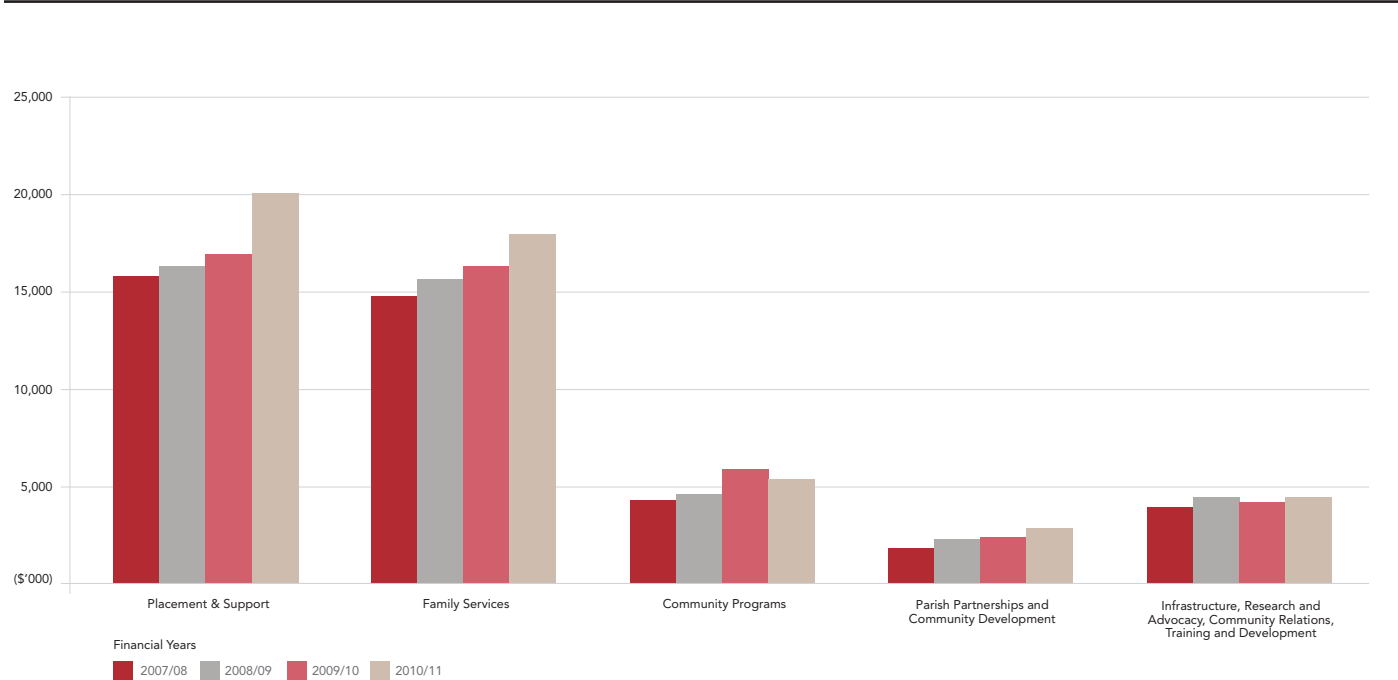

TRUSTS AND FOUNDATIONS

Thirteen philanthropic trusts provided grants totalling nearly \$800,000 in support of 19 programs and initiatives in the past year. This support is fundamental to us being able to respond to the urgent needs of children, young people and families across Victoria.

HIGHLIGHT

The most significant contribution received was from the Flora & Frank Leith Charitable Trust. Their grant has enabled us to develop a program offering greater support for young people transitioning from living in care to living independently. The goal of the initiative being piloted in Melbourne's North Western region is to encourage the educational and vocational opportunities and outcomes of this particularly disadvantaged group.

CORPORATE PARTNERS

There are many ways that businesses have supported the work of Anglicare Victoria in their community over the past year. Whether it is by attending our successful Dinner with the Angels event or the new Winter Breakfast, providing in-kind support, pro bono work or volunteers, all are important and vital in supporting vulnerable people.

HIGHLIGHT

ACS Financial continued their outstanding support of Anglicare Victoria this year by becoming an official corporate partner and affirming their shared vision of social justice. The significant financial contribution of the fleet and insurance provider will support a range of community programs. Their staff have been volunteering at various sites including Dixon House, the Lazarus Centre breakfast program and Mission House. We are excited about the ongoing and evolving partnership with ACS Financial and the opportunities it brings for our clients.

COMMUNITY PARTNERS

We are lucky to have the support of many schools, parishes, church and auxiliary groups who all contribute to our work in a variety of ways. Over the past year, 51 of these community partners contributed \$168,085 in financial support. In addition to this, many more organisations and schools have contributed through educational programs and contributing material aid.

HIGHLIGHT

Yarra Valley Grammar is one such group that looks for innovative ways to support our work and raise awareness of social justice among its students. In November, twenty students visited St Mark's Community Centre for a 'homeless experience school camp' in which they slept overnight in the community hall, attended the homeless breakfast program where they could interact with clients and attended education sessions based on urban issues. The students were given the challenge of giving up their mobile phones and money so they could experience inner city living without the luxuries many of us take for granted. The school community also regularly contributes in-kind donations of toys, food and blankets to our Emergency Relief sites.

CARE PARTNERS

Generous Care Partners have continued to provide essential funds for our work supporting children and families through regular monthly giving.

This year, as well as providing food for families in need and helping us to respond to unexpected crises, Care Partners enabled over 50 of our young clients to have the opportunities most children take for granted – from a family holiday to swimming lessons.

As David Clutterbuck said when he recently increased his monthly Care Partner donations, "Anglicare Victoria is important to me because they care, and I know that my small donations are going to people who are most in need".

BEQUESTS

This year we received \$144,000 from gifts left in the Wills of Anglicare Victoria supporters. Bequests form a lifeline between those making the bequest and Anglicare's clients. It is a final, everlasting gift that clients will see the benefit of for many years to come. To those who made a bequest we thank you and your families for supporting Anglicare.

HIGHLIGHT

We are delighted to announce that Jenny Disney, one of the original Friends of Anglicare Victoria has made the decision to leave a bequest to Anglicare Victoria. Jenny said that "when I think of my own grandchildren (aged 4 and 6), I realise that they are blessed. There are far too many children that grow up in households where there are financial difficulties, unemployment, no certainty of housing nor the advantage of a supportive wider family. I would like to think that through my bequest to Anglicare Victoria that they will be able to continue to provide services to people in need."

PUBLIC APPEALS

Our appeals give individuals, businesses and organisations the opportunity to support Anglicare clients through priority projects. The four public appeals this year raised in excess of \$920,000.

HIGHLIGHT

In March 2011, the Think Big Appeal was launched to support our enhanced efforts to help children in care to succeed at school. You, our supporters, really took on the challenge to Think Big with many of you increasing your gift level from the same time in 2010. Donations exceeded target and close to \$95,000 was raised to be invested in improving educational outcomes for children in our care by using strategies including tutoring and homework clubs as well as providing resources like laptops, books and stationery. A number of people also expressed an interest in supporting aspects of the education project at a higher level.
